



## Guidelines For 2004 Charitable Donations

### **PROVINCIAL ASSOCIATIONS, ORGANIZERS and ATHLETES**

**EVENTING CANADA [!]** is recognized by Revenue Canada as an Amateur Athletic Association. It is registered under 88721 5275 RR0001. The Association is in a position to provide tax creditable receipts for "arms length" donations which support the Association's mandate to develop the sport of Three Day Eventing and Horse Trials in Canada.

**Organizers** and **Provincial Associations** can use the National Association's charitable status to attract cash donations from individuals and corporations.

**Long, Short, Talent Identified, Young Riders** and dedicated **Amateurs** can offer those sponsors, who are not family members, charitable donation receipts for 100% of the cash contribution.

Disbursements from donated sources can only be claimed by the submission of original receipts supporting the Athlete's cost of training and competing; Organizers and Association should submit course construction or clinic costs.
